## 1. Newborn & Birth Defect Surveillance Reporting Structure:

(Surveillance & Reporting is mandatory for all Delivery Points)

All the birth defects identified at facility level (DH/SDH/CHC/PHC), Community level (during home based post-natal visits by (ASHA/ANM) to be DEIC and to be uploaded in HNBD portal. Further, all the birth defects reported in HNBD portal to be verified by DEIC Incharge/ Pediatrician at the District level. Deputy Civil Surgeon (RBSK) will be the nodal officer for implementation of newborn birth defects surveillance in the state.
